Having regard to Regulation (EU) 2019/1149 of the European Parliament and of the Council establishing a European Labour Authority, amending Regulations (EC) No 883/2004, (EU) No 492/2011, and (EU) 2016/589 and repealing Decision (EU) 2016/344¹ ("the Founding Regulation" and "the Authority"), and in particular Article 44(1) thereof;

HAS DECIDED AS FOLLOWS:

Article 1

The Requirements for the Financial Autonomy of ELA, as set out in the annexed document are hereby adopted.

Article 2

The Executive Director will prepare an Assessment Report on the requirements set on the basis of which, the Management Board will decide upon the date of ELA's financial autonomy.
