

# Decision No 8/2022 of 15 June 2022

## of the Management Board

## on amending the European Labour Authority's Establishment Plan 2022

THE MANAGEMENT BOARD OF THE EUROPEAN LABOUR AUTOHORITY.

Having regard to Regulation (EU) 2019/1149 of the European Parliament and of the Council of 20 June 2019 establishing the European Labour Authority ("the Authority") amending Regulations (EC) No 883/2004, (EU) No 492/2011, and (EU) 2016/589 and repealing Decision (EU) 2016/344, and in particular Articles 32 and 33 therein,

Having regard to the ELA Financial rules, adopted by a Management Board by Decision No 21/2020 of 15 December 2020, and in particular Article 38 thereof,

Having regard to the Decision No 25/2021 of 17 December 2021 of the Management Board on Budget 2022,

HAS DECIDED AS FOLLOWS:

#### Article 1

ELA's establishment plan 2022 is hereby amended using Article 38 of its Financial Rules (10 % flexibility rule) by:

- adding one temporary post AD11 instead of one AD10,
- adding two temporary posts AD8 instead of one AD7 post and one AD6 post,
- adding one temporary post AST5 instead of one AST4 (See Annex 1).

### Article 2

This decision shall enter into force on the day of its adoption.
