

# Decision No 05/2023 of 16 June 2023 of the Management Board amending the Single Programming Document of the European Labour Authority for 2023-2025

THE MANAGEMENT BOARD OF THE EUROPEAN LABOUR AUTHORITY,

Having regard to Regulation (EU) 2019/1149 of the European Parliament and of the Council of 20 June 2019 establishing a European Labour Authority, amending Regulations (EC) No 883/2004, (EU) No 492/2011, and (EU) 2016/589 and repealing Decision (EU) 2016/344<sup>1</sup> ("the Founding Regulation" and "the Authority"), and in particular Articles 18(1) (s) and 24 thereof,

Having regard to the Decision No 21/2020 of 15 December 2020 of the Management Board on ELA's Financial Rules, and in particular Article 32 thereof,

Having regard to the Decision No 12/2022 of 23 November 2022 of the Management Board on the Single Programming Document of the European Labour Authority for 2023-2025 (SPD 2023-2025),

Whereas:

- (1) The procurement plan of the Authority forms part of Annex III to the SPD 2023-2025 and provides the estimation of the contracts' value to be procured by the Authority.
- (2) The procurement plan should be revised to be better aligned with the needs of the Authority and to further improve implementation of the Authority's budget.
- (3) The revised procurement plan provides more structured and detailed information about the Authority's plans to launch procurement procedures related to the operational activities of the Authority referred to in SPD 2023-2025.
- (4) The indicative values of the contracts included in the procurement plan referred to the total value of the contracts during the entire period of their duration with the objective to further improve multi-annual budget planning of the Authority.

#### 2023 procurement plan

The 2023–2025 SPD, including the 2023 ELA annual work programme, is equivalent to a financing decision for the activities it covers in line with Article 72 of ELA's financial rules2.
