

# Decision No 18/2023 of 21 November 2023 of the Management Board on amending the European Labour Authority's Establishment Plan 2023

## THE MANAGEMENT BOARD,

Having regard to Regulation (EU) 2019/1149 of the European Parliament and of the Council of 20 June 2019 establishing the European Labour Authority ("the Authority") amending Regulations (EC) No 883/2004, (EU) No 492/2011, and (EU) 2016/589 and repealing Decision (EU) 2016/344, and in particular Article 25 thereof,

Having regard to the Decision of the Management Board No 21/2020 of 15 December 2020 on ELA's Financial Rules (hereafter: ELA's Financial Rules), , and in particular Article 38 thereof,

Having regard to the Decision of the Management Board No 13/2022 of 23 November 2022 on the budget 2023,

#### WHEREAS

- (1) ELA's establishment plan was adopted by the Decision of the Management Board No 13/2022.
- (2) ELA's Financial Rules allows the Management Board to modify the establishment plan provided that conditions contained in the Article 38 of ELA's Financial Rules are fulfilled.

HAS DECIDED AS FOLLOWS:

## Article 1

Amendment of ELA's establishment plan 2023

- 1. ELA establishment plan 2023 is hereby amended using Article 38 of ELA's Financial Rules (10 % flexibility rule) by:
  - adding two temporary posts AD11 instead of two AD10,
  - adding one temporary post AD9 instead of one AD8 post,

- adding one temporary post AD6 instead of one AD5 post,
- adding one temporary post AST5 instead of one AST4.
- 2. The amended ELA's establishment plan is annexed to this Decision.
