1. Introduction

The European Labour Authority (hereafter 'ELA') is committed to protect your personal data and to respect your privacy. ELA collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data (repealing Regulation (EC) No 45/2001).

This privacy statement explains the reason for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data in the context of "Projects related to ELA website and its campaign site and subsites – ELA web user survey". It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation "ELA web user survey", in particular. This survey supports the project of improvement of the corporate website carried on by the ELA, with the aim of collecting feedback from users.

2. Why and how do we process your personal data?

Purpose of the processing operation: The external contractor, NETCOMPANY - INTRASOFT SA on behalf of ELA Communications Sector collects and uses your personal information to obtain relevant knowledge on the user experience related to the ELA website. The data are used to feed the Authority's performance monitoring framework including external evaluations and performance indicators and for learning and improvement purposes.

A targeted consultation is necessary to obtain the users' feedback on their journeys and experiences on the ELA website, in order to inform the ELA further user experience improvements projects.

Your personal data will not be used for an automated decision-making including profiling.

3. On what legal ground(s) do we process your personal data

We process your personal data, because, according to Article 5(1)(d) of Regulation (EU)2018/1725, you have given consent to the processing of your personal data for one or more specific purposes.

We do not process **special categories of personal data**, therefore, Article 10 of the abovementioned Regulation does not apply.

4. Which personal data do we collect and further process?

Only personal data necessary for participation in the study will be collected and processed. In order to carry out this processing operation NETCOMPANY - INTRASOFT SA on behalf of ELA Communications Sector collects the following categories of personal data:

- job category
- country of residence,
- accessibility needs when using websites
- personal data included in the response or contribution to the study, including (personal) opinions
- consent form

Furthermore, respondents may spontaneously provide other, non-requested personal data in the context of their reply to a targeted consultation. In all other cases, it is the responsibility of the respondents who opted for confidentiality of their personal data to avoid any reference in the submissions that would reveal their identity.

The provision of personal data is not mandatory.

5. How long do we keep your personal data?

Upon completion of the task, NETCOMPANY - INTRASOFT SA will delete the data from their database. The data will remain securely stored within the EU Survey platform, a service operated by the European Commission and covered by Record "DPR-EC-01488 EUSurvey". Access will be granted only to ELA. ELA only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing, namely for 12 (twelve) months period after the end of the survey.

In case of publication of replies to a specific survey, after obtaining explicit consent of the data subject, data could be kept for 5 years.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored either on the servers of the European Labour Authority or of its contractors.

ELA's contractors are bound by a specific contractual clause for any processing operations of your data on behalf of ELA, and by the confidentiality obligations deriving directly from the General Data Protection Regulation in the EU Member States ('GDPR' [Regulation \(EU\) 2016/679](#).)

In order to protect your personal data, ELA has put in place a number of technical and organisational measures in place. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to ELA staff responsible for carrying out this processing operation and to authorised staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

The external contractor staff will have access to specific parts of the personal data on a need to know basis during the performance of the survey. After the survey is done (1 year from the end of the survey), the external contractor will delete all personal data related to the study.

When explicitly agreed by you, some of your personal data (the views expressed by the respondents to the survey, job category or country of residence of the respondent) will be published on a publicly available website on a Europa website, either as received, in the form of a summary report, included in a wider policy document, or printed to illustrate communication material, etc.

Please note that pursuant to Article 3(13) of the Regulation, public authorities (e.g. Court of Auditors, EU Court of Justice) which may receive personal data in the framework of a particular inquiry in accordance with Union or Member State law shall not be regarded as recipients. The processing of those data by those public authorities shall be in compliance with the applicable data protection rules according to the purposes of the processing.

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

8. What are your rights and how can you exercise them?

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have consented to provide your personal data to NETCOMPANY - INTRASOFT SA for the present processing operation. You can withdraw your consent at any time by notifying the Data Controller. The withdrawal will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified under Heading 10 below) in your request.
