The European Labour Authority ('the Authority' or 'ELA') is a Union body in the area of cross-border labour mobility. Its aim is to facilitate access for individuals and employers to information on their rights and obligations; support cooperation between EU countries in the cross-border enforcement of relevant Union law, including by facilitating joint inspections; support Member States in tackling undeclared work and mediate and facilitate a solution in cases of cross-border disputes between national authorities.

The job

The Authority is launching a vacancy notice with a view to establishing a reserve list of Contract Agents for a position of Legal and Data Protection Officer (CA FG IV).

1. Profile

The Legal and Data Protection Officer shall support the legal team with a particular focus on the data protection and legal administrative activities contributing to ELA's legal compliance.

1.1. Tasks

Reporting to the Head of the Executive Director's Office, Legal and Compliance, the tasks of the Legal and Data Protection Officer will include supporting the legal and compliance sector, inter alia:

- Providing legal advice on the implementation and interpretation of ELA founding Regulation and institutional framework;

- Providing legal advice on the interpretation and implementation of the Data Protection Regulation (UE) 2018/1725¹;
- Providing legal support on ELA's administrative activities (HR matters and staff cases, contracts and procurement, facilities and ICT, etc.);
- Providing legal support by, i.e. drafting decisions, opinions, administrative notes, rules, administrative notices and other acts in line with ELA legal framework;
- Acting, based on the need of the service, as (deputy) Data Protection Officer for ELA²;
- Providing support in the legal frameworks of AI and cybersecurity;
- Performing any other related task in the interest of the service.

Qualifications and experience required

2. Eligibility criteria

By the closing date for applications to this vacancy notice, candidates must fulfil the requirements below:

2.1. General conditions

- be a national of a Member State of the European Union;
- enjoy their full rights as citizens³;

- a) ensuring that the Agency internally applies Regulation (EU) 2018/1725, including in the context of the obligations applicable to the large-scale IT systems, new technologies and challenges (i.e. AI, cybersecurity);
- b) ensuring controllers and data subjects are informed of their rights and obligations;
- c) providing opinions and advice to ELA services on processing personal data, on the need to perform a data protection impact assessment (DPIA), personal data risk assessments and change management processes;
- d) Building and maintaining the register of personal data processing operations;
- e) Compiling and maintaining the overall data protection files at ELA;
- f) Hearing and examining complaints and other requests from data subjects and conducting inquiries in the area of responsibility when is requested and not conflicting with the position of the DPO;
- g) Investigating issues and facts related to possible breach of data protection legal framework provisions and report accordingly;
- h) Monitor, assess, provide advice as regards personal data breaches and keeping a centralised register of personal data breaches;
- i) Consulting, responding to requests and cooperating with the European Data Protection Supervisor ('EDPS') at their request or on the data protection officer's own initiative, including notification of high-risk processing operations and organising internally for the systems EDPS audits;
- j) Cooperating with the controller on data protection impact assessments for processing operations;
- k) Contributing to disseminating best practices and drafting guidelines and procedures promoting privacy-by-design and by default principles;
- l) Participating in data protection meetings, inter-institutional cooperation and exchanges with other EU Institutions and bodies and representing the Agency towards Supervision Coordination Groups related to large-scale IT systems;
- m) Reporting regularly to the Executive Director and Management Board according to the Agency's procedures.

- have fulfilled any obligations imposed by national laws concerning military service;
- meet the appropriate personal and professional requirements for the duties involved;
- be physically fit to perform their duties⁴;

2.2. Language skills

Candidates must have a thorough knowledge of one official language of the European Union and a satisfactory knowledge⁵ (level B2) of another language of the Union⁶. As the predominant working language of ELA is English, candidates must have an excellent command of spoken and written English⁷.

2.3. Education

Candidates must have at the closing date for applications, a level of education which corresponds to a university degree attested by a diploma in Law when the normal period of university education is at least three (3) years.

Candidates must indicate in their applications the official graduation dates for all the diplomas they have obtained.

3. Selection criteria

3.1 Essential:

- Proven professional experience of at least two (2) years relevant to the tasks described under section 1.1. acquired in international and/or multicultural environment, preferably in EU institutions, Agencies or bodies;
- Professional experience in the implementation of the Data Protection Regulation (EU) 2018/1725 either in the role of (Deputy) Data Protection Officer or Data Controller;
- Excellent knowledge of the EU legal framework, including institutional legal processes and procedures;
- Proficiency in English (level C1)⁸.

3.2 Advantageous:

- Professional experience in providing legal advice in the implementation of EU Staff Regulations of Officials and Conditions of Employment of Other Servants;
- Professional experience in providing legal advice in contract law or in the implementation of the EU Financial Regulations, including public procurement, contractual matters;
- Professional experience in providing legal advice in Union law, such as EU Employment Law, EU Administrative Law, EU Internal Market Law;
- Knowledge and/or experience with cybersecurity and AI legal frameworks;

Moreover, the following competencies may be assessed during the selection process:

- Digital Expertise;
- Prioritising and Self-management;
- Driving for results;
- Creative Problem Solving;
- Effective Communication.

The selection process

4. Before applying, you should carefully check whether you meet all the eligibility criteria.

Applications must include a motivation letter and a CV, both submitted in English to be considered. **Applications not submitted in English will be excluded from the selection procedure.**

To be able to apply via EU CV Online, you must first create an account or sign in to an existing account. If not done already, you must first fill in the electronic CV. Once the CV is completed, you may choose and apply to the call for expressions of interest of your choice. You are advised to fill out ALL relevant fields of the application. For guidance, please refer to the guidelines for applications to candidates in [ELA's website](#).

Only complete applications registered via EU CV Online before the deadline will be considered. Please note that the selection committee can only take into account the information

It is your responsibility to complete your online registration in time. 5. Steps of the selection procedure

5.1. Admission to the selection procedure

After the deadline for online registration, the selection committee will check the submitted applications against the **eligibility criteria** described in Section 2.

The selection committee will analyse if the application was submitted in English. Applications not submitted in English will be excluded from the selection procedure.

Applications satisfying all these conditions will then be initially assessed against the **selection criteria** under Section 3.

5.2. Initial assessment of the eligible applications

The selection committee will assess each eligible application with reference to the selection criteria ("Essential" and "Advantageous") described in Section 3.

Upon completion of the assessment, the selection committee will establish a shortlist of candidates to be invited to the assessment phase.

Please note that once the pre-assessment phase is completed, shortlisted candidates will be invited to the assessment phase. The remaining candidates will be notified, by email, that their application will no longer be taken into consideration.

5.3. The assessment phase

Following the initial assessment of the applications, shortlisted candidates will be invited to the assessment phase, which will be held online. The assessment phase will be conducted in English.

Details of the date and time of the assessment will be communicated to the shortlisted candidates in due time.

The assessment phase involves an interview with the selection committee and one or more test(s) related to the field of the vacancy. This phase will enable the selection committee to carry out an assessment of the pre-selected candidates according to the selection criteria described in Section 3.

5.4. Verification of documents and scrutiny

If, at any stage in the procedure, it is established that the information in an application has been knowingly falsified or incorrect, the candidate will be disqualified from the selection process.

Candidates will also be disqualified if they:

- do not meet all the eligibility criteria;
- do not provide all the required supporting documents.

Prior to the assessment phase, the shortlisted candidates will be required to provide via email a copy of their documents proving their eligibility, mainly their academic diplomas and evidence of their professional experience clearly indicating the starting and finishing dates, the function(s) and the exact nature of the duties carried out.

Prior to the signature of the contract, the successful candidates must present original versions of documents proving the eligibility criteria and of their experience.

5.5. Reserve list

The selection committee will place the most suitable eligible candidates on a draft reserve list. This draft will be submitted to the Executive Director of ELA for approval. The adopted reserve list will be valid until 31 December 2025. The validity of the reserve list may be extended by decision of the Executive Director of ELA. The information on valid reserve lists of ELA is published on [ELA's website](#).

Prior to being offered a post, candidates on a reserve list may be required to undergo further evaluation by ELA (e.g. including a further interview with the Executive Director).

Candidates should note that the inclusion on the reserve list does not imply any entitlement to employment in ELA.

Other important information

6. General information

6.1. Equal opportunities

The Authority is an equal opportunity employer and strongly encourages applications from all candidates who fulfil the eligibility criteria and interested in the position. ELA ensures that its recruitment procedures do not discriminate on the grounds of gender, colour, race, ethnic or social origin, genetic features, language, religion or belief, political or any other opinion, membership of a national minority, property, birth, disability, nationality, age, sexual orientation or gender identity.

6.2. Selection committee

A selection committee is appointed for each selection procedure. The selection committee is composed of at least three (3) members, including a member designated by the Staff Committee.

Please note that the selection committee's internal proceedings are strictly confidential and that any contact with its members is strictly forbidden. Under no circumstances should candidates approach the selection committee, either directly or indirectly, concerning the selection procedure. Any infringement of this rule will lead to the disqualification from the selection procedure.

6.3. Approximate timetable

The selection process may take some months to be completed. The selection committee intends to finalise the recruitment process as soon as possible for this vacancy by June 2025, with a view for the selected candidate to take office by August 2025, or earlier.

The foreseen timeframe for the selection procedure will be updated on [ELA's website](#).

Please note that once the pre-assessment phase is completed, shortlisted candidates will be invited to the assessment phase. The remaining candidates will be notified, by email, that their application will no longer be taken into consideration.

6.4. Engagement and Conditions of employment

The decision on appointment will be taken by the Authority's Executive Director as the Authority Empowered to Conclude Contracts of Employment on the basis of the reserve list of most suitable candidates.

Before engaging a contract agent, the Executive Director will examine whether the candidate has any personal interest such as to impair his/her independence or any other conflict of interest. The candidate will inform the Executive Director, using a specific form of any actual or potential conflict of interest¹¹. If necessary, the Executive Director shall take any appropriate measures.

A contract may be offered for contract agent pursuant to Article 3(a) of the Conditions of Employment of Other Servants of the European Union (CEOS) for an initial period of 5 years, renewable once. After the second period, the contract may be renewed for an indefinite period. The jobholder will be subject to a probationary period of 9 months.

6.5. Job environment

The place of employment is Bratislava, Slovakia. Residence within reasonable distance of ELA's office is defined in accordance with the Staff Regulations (Article 20).

The jobholder will work in a multicultural, respectful and appreciative environment, which offers the possibility to shape the work of the authority, where collaboration and open and constructive dialogue is encouraged, while building effective work relations.

Working time is based on a 40-hour working week. ELA offers flexible working arrangements such as teleworking, part-time work, and flexible working hours.

6.6. Pay and welfare benefits

The successful candidate who is offered a contract of employment will, on their entry into service, **be placed in Grade 13, 14 or 16 of FG IV**, according to their qualifications and length of professional experience.

The staff member's remuneration consists of a basic salary and allowances. It is paid in euro **weighed down by the correction coefficient** (in Slovakia the correction coefficient is currently 84,2% compared to Belgium).

The gross basic salary, after correction coefficient is applied, is as follows¹²:

In addition to the basic salary, staff **may be** entitled to various **allowances** depending on their particular situation. These may include:

- **Household allowance** (e.g. if you have a dependent child or you are married and your spouse's income is below a defined threshold);
- **Dependent child allowance** (e.g. if you have a child under the age of 18 or between 18 and 26, if in specified training programme);
- **Education allowances** (Pre-school or Education allowance) **or Payment of the education fees applicable to selected educational institutions;**
- **Expatriation allowance or foreign residence allowance** (16% of the sum of basic salary and other applicable allowances) or foreign residence allowance (4 %).

¹² Amounts are indicated for information purposes and may vary by the time the selected candidate takes up his/her duties following the annual revision of the remuneration.

The salary is subject to a Community tax deducted at source and is exempt from national tax. The salary package includes contributions to the EU social security and pension schemes. Candidates are invited to familiarise themselves with the employment conditions as stated in the [Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Union](#).

Under certain circumstances, in particular where the jobholder is obliged to change his/her place of residence in order to take up employment, the Agency may also reimburse some expenses incurred on recruitment, notably removal expenses.

Additional benefits:

- Annual leave entitlement of two days per calendar month plus additional days for age, grade, 2.5 days' home leave, if applicable, and in addition on average 18 public holidays per year;
- Special leave granted for certain circumstances: e.g. removal, marriage, birth of a child, etc.;
- Various training opportunities;
- Social measures;
- EU Pension scheme (granted after 10 years of service);
- EU Joint Sickness Insurance Scheme (JSIS), accident and occupational disease coverage, unemployment and invalidity allowance and insurance.

6.7. Protection of personal data

Personal data shall be processed exclusively for the purpose of this selection procedure. The purpose of processing the data submitted by candidates is to evaluate applications in view of possible recruitment at ELA.

6.8. Appeal procedure

Administrative complaints

If a candidate considers that they have been adversely affected by a particular decision, they can lodge a complaint under Article 90(2) of the Staff Regulations of Officials and Conditions of Employment of Other Servants of the European Union.

The complaint must be lodged within 3 months. The time limit for initiating this type of procedure (see Staff Regulations as modified by Council Regulation No 723/2004 of 22 March 2004 published in the Official Journal of the European Union L 124 of 27 April 2004 – <http://europa.eu/eur-lex>) starts to run from the time the candidate is notified of the act adversely affecting him/her. The complainant shall clearly indicate the selection procedure reference number and the decision they wish to contest and on what grounds.

Judicial appeals

Should the complaint be rejected, the candidate may request judicial review of the act adversely affecting him/her pursuant to Article 270 of the Treaty on the Functioning of the European Union and Article 91 of the Staff Regulations, before the General Court:

European Ombudsman

It is also possible to complain to the European Ombudsman. Any citizen of the European Union or any natural or legal person residing in a Member State may direct a complaint concerning instances of maladministration to the European Ombudsman pursuant to Article 228(1) of the Treaty on the Functioning of the European Union and in accordance with the conditions laid down in the Decision of the European Parliament of 9 March 1994 on the regulations and the general conditions governing the performance of the Ombudsman's duties, published in the Official Journal of the European Union L113 of 4 May 1994:
