on the replacement of expert of the Mediation Board appointed by Management Board

Decision No 07/2025 of 17 June 2025

THE MANAGEMENT BOARD OF THE EUROPEAN LABOUR AUTHORITY,

Having regard to Regulation (EU) 2019/1149 of the European Parliament and of the Council of 20 June 2019 establishing a European Labour Authority, amending Regulations (EC) No 883/2004, (EU) No 492/2011, and (EU) 2016/589 and repealing Decision (EU) 2016/344¹ (“the founding Regulation” and “the Authority”), and in particular Article 13 thereof,

Having regard to Decision No 06 of 6 May 2026 of the Management Board

on the Rules of Procedure for mediation of the European Labour Authority, and in particular Article 7(4) thereof;

Whereas:

- (1) The Rules of procedure for mediation of the European Labour Authority provide for the Management Board to appoint an adequate number of mediators and experts from the Member States who will sit on the Mediation Board.
- (2) The Management Board should ensure that the list of appointed mediators and experts of the Mediation Board achieves the necessary geographical, professional, and gender balance. Persons nominated for mediators should possess the necessary knowledge and skills in the field of dispute resolution mechanisms including mediation, and preferably, basic knowledge related to any of the different areas within the scope of the mediation procedure. Persons nominated as experts of the Mediation Board shall possess the requisite expertise and competence for dealing with disputes related to any of the different areas within the scope of the mediation procedure.
- (3) The Authority should keep the list of mediators and experts of the Mediation Board updated.

- (4) In order to ensure the continuity of the mediation procedure and as stipulated by Article 7(4) of the Rules of Procedure for mediation of the European Labour Authority, the list should be automatically extended beyond that period for as long as a new list has not been established. If an appointed mediator or expert of the Mediation Board leaves before the expiry of this term, the Management Board should appoint a replacement for the remaining period.
- (5) Decision No 7/2025 of 17 June 2025 of the Management Board on the appointment of mediators, Chair, Deputy Chairs, and experts of the Mediation Board (hereafter: Decision No 7/2025) should be amended accordingly;

HAS DECIDED AS FOLLOWS:

Article 1

The Decision No 7/2025 of 17 June 2025 of the Management Board on the appointment of mediators, Chair, Deputy Chairs, and experts of the Mediation Board of the European Labour Authority is hereby amended by:

- appointing KACHEEVA Maria (BE) as expert of the Mediation Board, replacing VAN STEENKISTE Lode (BE) for the remaining term.

Article 2

The list of appointed mediators, experts of the Mediation Board, a Chair, and two Deputy Chairs is hereby amended and annexed to this Decision.

Article 3

Entry into force

This Decision shall take effect the day following its adoption.
